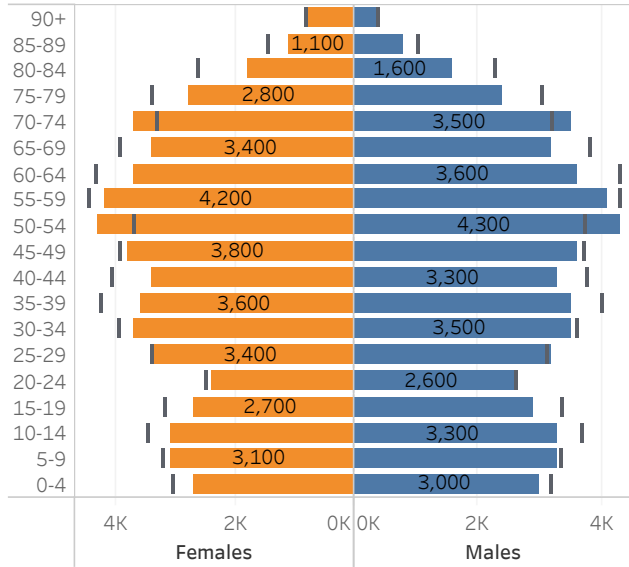

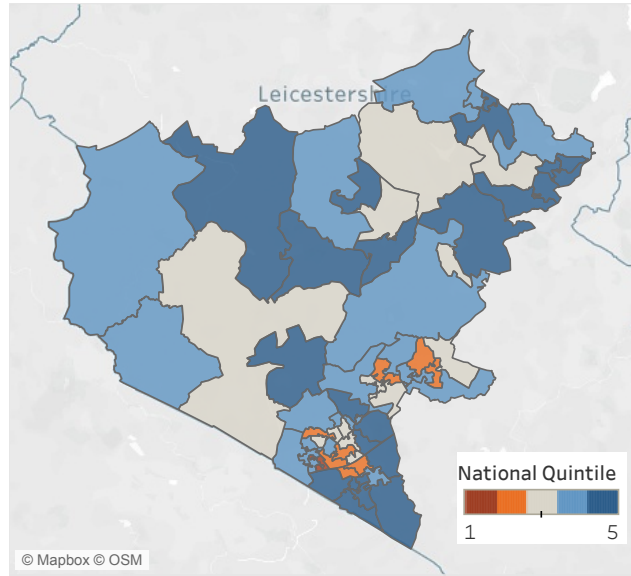
Population pyramid

Age and sex profile of residents, bars indicate 2021 census population, lines show projected 2027 population.



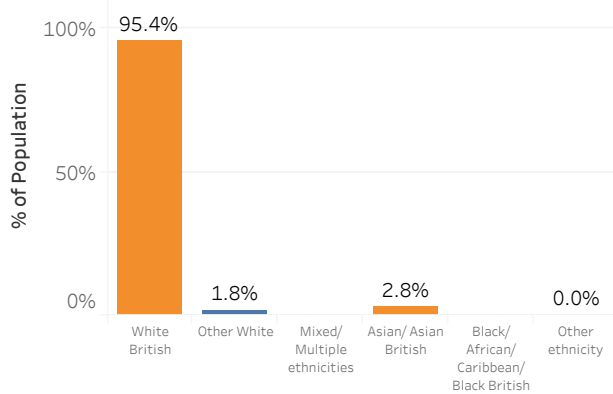
Index of Multiple Deprivation map

LSOA map showing national quintile performance of index of multiple deprivation score.



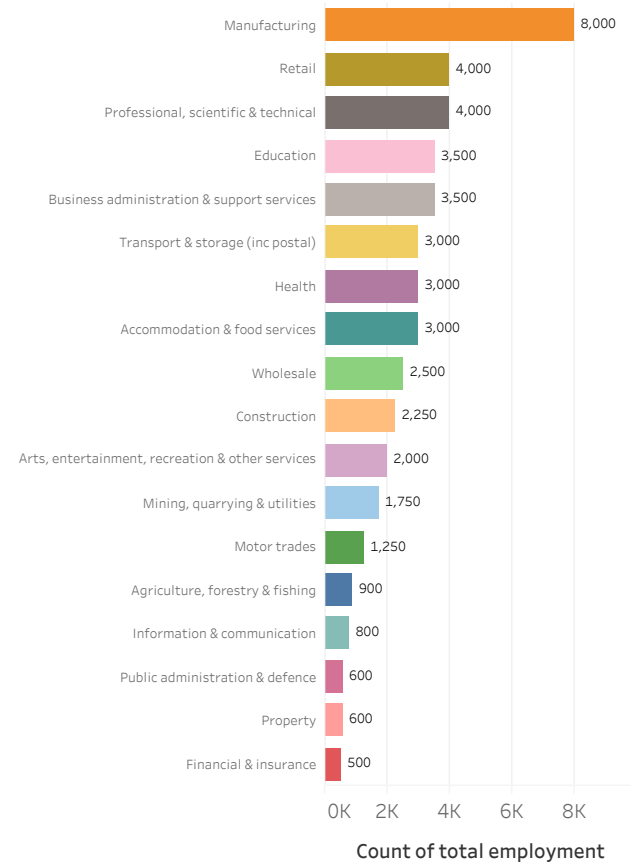
Ethnicity

Wider determinants

The number of premises licensed to sell alcohol per square kilometre for Hinckley and Bosworth in 2017/18 is 1.2 this is similar to the England value of 1.3.



The density of fast food outlets for Hinckley and Bosworth in 2014 is 67.8 per 100,000 this is significantly better than the England value of 88.2 per 100,000.



The air pollution: fine particulate matter (historic indicator) for Hinckley and Bosworth in 2020 is 6.6 µg/m3 this is not compared to the England value of 6.9 µg/m3.



The proportion of unpaid carers for Hinckley and Bosworth in 2011 is 2.4% this is similar to the England value of 2.4%.



The average weekly earnings for Hinckley and Bosworth in 2021 is £466.7 this is similar to the England value of £496.0.



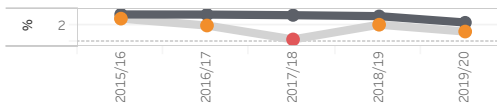
The gap in the employment rate between those with a long-term health condition and the overall employment rate for Hinckley and Bosworth in 2019/20 is 0.8 percentage points this is significantly better than the England value of 10.6 percentage points.



The violence offences per 1,000 population for Hinckley and Bosworth in 2020/21 is 22.6 per 1,000 this is not compared to the England value of 29.5 per 1,000.



The percentage of adults cycling for travel at least three days per week for Hinckley and Bosworth in 2019/20 is 1.2% this is similar to the England value of 2.3%.



The affordability of home ownership for Hinckley and Bosworth in 2021 is 7.5 this is not compared to the England value of 9.1.

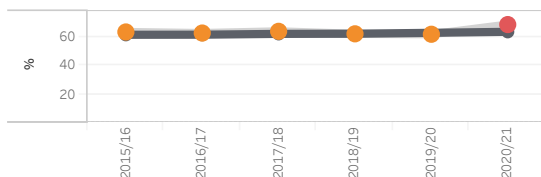


The percentage of the population living in fuel poverty for Hinckley and Bosworth in 2018 is 9.0% this is not compared to the England value of 10.3%.



Health behaviours

The percentage of adults (aged 18+) classified as overweight or obese for Hinckley and Bosworth in 2020/21 is 68.5% this is significantly worse than the England value of 63.5%.



The smoking prevalence in adults (18+) - current smokers (APS) for Hinckley and Bosworth in 2019 is 10.4% this is similar to the England value of 13.9%.



The percentage of physically active adults for Hinckley and Bosworth in 2020/21 is 61.5% this is significantly worse than the England value of 65.9%.



The proportion of the population meeting the recommended '5-a-day' on a 'usual day' (adults) for Hinckley and Bosworth in 2019/20 is 52.1% this is similar to the England value of 55.4%.

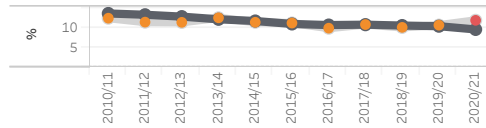

Early years

The proportion of low birth weight of term babies for Hinckley and Bosworth in 2020 is 1.4% this is significantly better than the England value of 2.9%.



The proportion of women smoking at time of delivery for Hinckley and Bosworth in 2020/21 is 11.9% this is significantly worse than the England value of 9.6%.



The infant mortality rate for Hinckley and Bosworth in 2018 - 20 is 2.5 per 1,000 this is similar to the England value of 3.9 per 1,000.

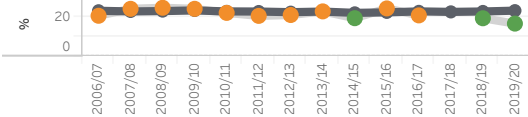


The breastfeeding initiation for Hinckley and Bosworth in 2016/17 is 66.4% this is significantly worse than the England value of 74.5%.

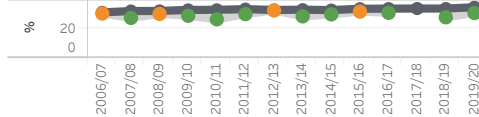


Wider determinants

The prevalence of overweight children (including obesity) in Reception for Hinckley and Bosworth in 2019/20 is 16.5% this is significantly better than the England value of 23.0%.



The prevalence of overweight children (including obesity) in Year 6 for Hinckley and Bosworth in 2019/20 is 31.2% this is significantly better than the England value of 35.2%.



The Pupil absence for Hinckley and Bosworth in 2018/19 is 4.3% this is significantly better than the England value of 4.7%.



The Children in absolute low income families (under 16s) for Hinckley and Bosworth in 2019/20 is 11.2% this is significantly better than the England value of 15.6%.



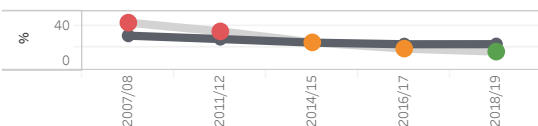
The percentage of children providing unpaid care (aged 0-15) for Hinckley and Bosworth in 2011 is 1.0% this is similar to the England value of 1.1%.



The average attainment 8 score for Hinckley and Bosworth in 2020/21 is 51.5 this is similar to the England value of 50.9.

Outcomes

The percentage of 5 year olds with experience of visually obvious dental decay for Hinckley and Bosworth in 2018/19 is 16.8% this is significantly better than the England value of 23.4%.



The rate of admission episodes for alcohol-specific conditions - Under 18s for Hinckley and Bosworth in 2018/19 - 20/21 is 29.6 per 100,000 this is similar to the England value of 29.3 per 100,000.



The rate of admissions caused by unintentional and deliberate injuries in children (aged 0-14 years) for Hinckley and Bosworth in 2020/21 is 55.2 per 10,000 this is significantly better than the England value of 75.7 per 10,000.



The under 18s conception rate for Hinckley and Bosworth in 2020 is 11.8 per 1,000 this is similar to the England value of 13.0 per 1,000.

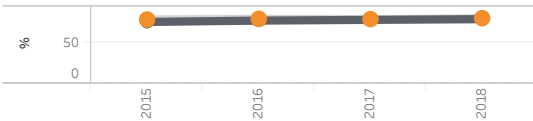

Diagnoses



The estimated diabetes diagnosis rate for Hinckley and Bosworth in 2018 is 79.1% this is similar to the England value of 78.0%.



The estimated dementia diagnosis rate (aged 65 and over) for Hinckley and Bosworth in 2021 is 64.1% this is similar to the target value of 66.7%.



The all new STI diagnosis rate / 100,000 for Hinckley and Bosworth in 2020 is 323.8 per 100,000 this is significantly lower than the England value of 562.2 per 100,000.



The Cancer screening coverage - breast cancer for Hinckley and Bosworth in 2021 is 56.0% this is significantly worse than the England value of 64.1%.

Admissions

The admission episodes for alcohol-related conditions (Broad): New method for Hinckley and Bosworth in 2020/21 is 1,284.3 per 100,000 this is significantly better than the England value of 1,499.8 per 100,000.



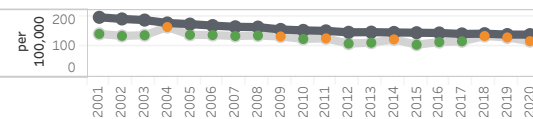
The rate of emergency hospital admissions due to falls in people aged 65 and over for Hinckley and Bosworth in 2020/21 is 1,887.9 per 100,000 this is similar to the England value of 2,023.0 per 100,000.



Mortality



The under 75 mortality rate from causes considered preventable (2019 definition) for Hinckley and Bosworth in 2020 is 119.1 per 100,000 this is similar to the England value of 140.5 per 100,000.



The suicide rate for Hinckley and Bosworth in 2018 - 20 is 8.6 per 100,000 this is similar to the England value of 10.4 per 100,000.



The under 75 mortality rate from cancer for Hinckley and Bosworth in 2017 - 19 is 121.5 per 100,000 this is similar to the England value of 129.2 per 100,000.



The under 75 mortality rate from all cardiovascular diseases for Hinckley and Bosworth in 2017 - 19 is 71.6 per 100,000 this is similar to the England value of 70.4 per 100,000.



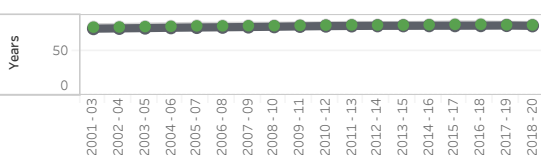
The under 75 mortality rate from respiratory disease for Hinckley and Bosworth in 2017 - 19 is 27.4 per 100,000 this is significantly better than the England value of 33.6 per 100,000.



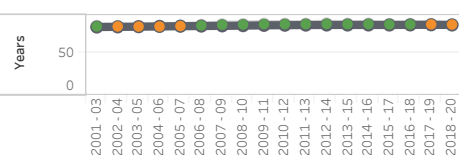
The excess winter deaths index for Hinckley and Bosworth in Aug 2019 - Jul 2020 is 17.5% this is similar to the England value of 17.4%.

Life Expectancy

The life expectancy at birth for males for Hinckley and Bosworth in 2018 - 20 is 80.4 years this is significantly better than England value of 79.4 years.



The life expectancy at birth for females for Hinckley and Bosworth in 2018 - 20 is 83.6 years this is similar to England value of 83.1 years.
